WARNING

It is a felony for anyone to sign any initiative or referendum petition with any name other than his own, or to knowingly sign his name more than once for the measure, or to sign such petition when he is not a qualified elector.

INITIATIVE PETITION

To the Honorable Ben Ysursa, Secretary of State of the State of Idaho:

"We, the undersigned citizens and qualified electors of the State of Idaho, respectfully demand that the following proposed law, to-wit:

Be it Enacted by the People of Idaho:

SECTION 1. That Chapter 6, Title 31, Idaho Code, be, and the same is hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and designated as Section 31-606, Idaho Code, and to read as follows:

31-606. MEMBERSHIP IN ORGANIZATIONS UNDERMINING U.S. SOVEREIGNTY

- A. No county established under this chapter can be a member of the International Council for Local Environmental Initiatives (ICLEI), any entity established by the United Nations, or any entity whose purpose is to undermine the sovereignty of the United States and restrict the natural rights of the people of the United States. No county established under this chapter shall provide and funding to or accept any funding from any such organization.
- B. Any county which has not terminated its membership in any organization specified in A. of this section within ten days of the effective date of this legislation, shall be fined by the State \$1,000 for each day they are still a member of such organization beyond the effective date of this legislation. Any county which accepts or provides funding to an organization as specified by A. shall be liable to the State of Idaho for ten times the amount of money accepted or contributed. There shall be no discretion for an attorney general's office not to prosecute violations of this act.

SECTION 2. That Chapter 2, Title 50, Idaho Code, be, and the same is hereby amended by the addition thereto of a <u>NEW SECTION</u>, to be known and designated as Section 50-237, Idaho Code, and to read as follows:

50-237. MEMBERSHIP IN ORGANIZATIONS UNDERMINING U.S. SOVEREIGNTY

- A. No municipal corporation established under this chapter can be a member of the International Council for Local Environmental Initiatives (ICLEI), any entity established by the United Nations, or any entity whose purpose is to undermine the sovereignty of the United States and restrict the natural rights of the people of the United States. No municipal corporation shall provide and funding to or accept any funding from any such organization.
- B. Any municipal corporation which has not terminated its membership in any organization specified in A. of this section within ten days of the effective date of this legislation, shall be fined by the State \$1,000 for each day they are still a member of such organization beyond the effective date of this legislation. Any municipal corporation which accepts or provides funding to an organization as specified by A. shall be liable to the State of Idaho for ten times the amount of money accepted or contributed. There shall be no discretion for an attorney general's office not to prosecute violations of this act.

SECTION 3. EFFECTIVE DATE. [This act] is effective as soon as it is approved by a majority of the votes cast thereon.

SECTION 4. SEVERABILITY. If a part of [this act] is invalid, all valid parts that are severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications, the part remains in effect in all valid applications that are severable from the invalid applications.
