


ICLEI




and the nation of Canada agreement is a clear violation of the federal Constitution!




American sovereignty is being stripped as the Constitution lives its way into globalism.

This is a map of the transnational region controlled by this transnational agreement:




Schweitzer should rescind this compact. Failing that he ought to be impeached as a traitor!


