Freedom Advocates promotes the unalienable rights of Life, Liberty and the pursuit of Happiness as expressed in the Declaration of Independence. Today many laws and policies implement Agenda 21/Sustainable Development which ignore and violate unalienable rights.

COGs and Regionalism

[Regionalism](#) is the transformed system of American government.

Regionalism is Extra Constitutional, it implements a [Soviet system](#).

Councils of Governments, known as COGs, have replaced local government and direct this regionalized system. Powers taken by COGs from cities and counties include: regional and municipal planning, economic and community development, cartography and GIS, hazard mitigation and emergency planning,

aging services, water use, pollution control, transit administration, and transportation planning.

ABAG is a COG.

Article 4 Section 4 of the U.S. Constitution requires that the federal government guarantee every state a Republican form of government. Infusion of COGs by the federal government into every state is a complete reversal of this mandate. COGs reflect a Sovietized form of government.

ABAG's actions pursue Agenda 21 objectives: *abolition* of private property, *dissolving* county and city boundaries, and the creation of *dense* "human settlements." There is virtually no public support, let alone awareness, of these actions in California other than from those who stand to obtain political advantages.

ICLEI is an international NGO that coordinates with the United Nations for purposes of implementing the action plan of Agenda 21 – the blueprint for sustainable development, leading to world government. "[The Local Agenda 21 Planning Guide](#)" was drafted by the ICLEI organization.

ICLEI has contracts with over 600 U.S. cities and 1200 cities around the world. The highest concentration of ICLEI city contracts in the world is in the San Francisco [Bay Area](#).

Article 1 Section 10 of the U.S. Constitution provides that no state (including subdivisions) may enter into any treaty, alliance or confederation with a foreign power.

California Penal Code Sections 37 and 38 dating from 1850 sets forth the procedure for noticing officials of treasonous activity occurring under their watch. Failure of local officials to rid local government of such an influence is itself a crime following such notice. Such a notice is called a *Misprision of Treason*.
